

The Japanese government finally decided to open the border for foreign tourists from June 10th under some restrictions.

Today, we are announcing you the details of COVID-19 infection control guidelines for foreign tourists.

- Please check the attached file for the procedure for visiting Japan for tourism purposes.
 The visitors should be from countries/regions in <u>Group "Blue"</u>.
- 2. "Guided Package Tour" identifies tours which are organized by a Japan-based travel agency or tour operator (like KNT).
 - The tours should be fully managed by tour conductors or the English (or your language) speaking guides arranged by local travel agency or tour operator.
 - * The tour conductors from countries other than Japan is not applicable.
- The hotels should be arranged by travel agency/tour operator.
 KNT would arrange the hotels which implements Covid-19 infection prevention measures, and are preferred by the Japanese government.
- Since there are certain procedure and service to be included in the tour, we will share our
 original packaged tours which follows the guideline very soon.
 - Though there is some conditions to meet, the tours can be customized on travelers' favor. Please be noted while we would announced the packaged tours, it does not mean that we do not accept any order-made tours.
- 5. Any business purposed contents such as visiting office in order to visit meetings, are not applicable.
- The travelers will be able to have free leisure time, within the area and time of the tour conductor's oversight. All participants must be reachable at all times.
- 7. While staying in Japan, the visitors should follow the instructions given by a tour conductor, such as to wear face masks.

At the moment, the concrete valid deadline for the guideline is not determined.

There is no limit for the maximum number of people in one group. However, please be noted that the cap on overseas arrival, which is 20,000 per day maximum.

Please be noted that reserving our package does not guarantee that the visitors would be within the 20,000 people, and it may be guaranteed by reserving international flights.

A Procedure for Visiting Japan for Tourism Purposes from Countries/Regions in Group "Blue"*

- 2 Apply for a Visa
 - 1. Your travel agency shall obtain the certificate for registration to ERFS* from the receiving organization in Japan.
 - 2. Apply for a visa at Embassies/Consulates with the ERFS* certificate received above.

3 Get a Covid-19 Negative Test Certificate

A Covid-19 test must be conducted within 72 hours prior to your departure. You can find **the format** for the test certificate at the MOFA* website.

4 Install MySOS app for Quarantine Fast Track

Install <u>the app</u>, answer the questionnaire, and register the Covid-19 Negative Test Certificate for smoother quarantine procedures at major airports.

 Regardless of vaccination status, any form of isolation after entry is not required.
