## PAYMENT & CANCELLATION POLICY

### PAYMENT TERMS

10% Initial Deposit when our proposal is accepted (10% Non-refundable)  
100% of estimated total cost due by 21 days prior to group arrival (minus deposit amount made prior to this date)

### CANCELLATION POLICY:

\* timing of notice of cancellation is based on Japan local time.

### Accommodation:

No cancellation penalty if cancelled 35 days prior to group arrival.  
30% cancellation penalty if cancelled between 34 days and 25 days prior to group arrival.  
50% cancellation penalty if cancelled between 24 days and 14 days prior to group arrival.  
80% cancellation penalty if cancelled between 13 days and 8 days prior to group arrival.  
100% cancellation penalty if cancelled within 7 days and no notice of cancellation.

### Golf Venue:

No cancellation penalty if cancelled 16 days prior to group arrival.  
20% cancellation penalty if cancelled between 15 days and 13 days prior to group arrival.  
30% cancellation penalty if cancelled between 12 days and 8 days prior to group arrival.  
50% cancellation penalty if cancelled between 7 days and 4 days prior to group arrival.  
100% cancellation penalty if cancelled within 3 days and no notice of cancellation.
